

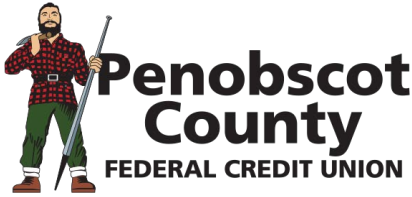


PCFCU Holiday Skip-A-Payment

Holiday Skip-A-Payment Rules

1. A finance charge of \$25.00 per loan will be deducted from your account. If you do not have available funds in your account, please mail a check for \$25.00 per loan included on this Holiday-Skip-A-Payment application.
2. No loans on your account can be past due at the time of the request. The following loans are not eligible: VISA's, Real Estate Loans, Home Equity Loans, Business Loans, and Student Loans. Only consumer loans opened for more than 90 days are eligible. All applications are subject to the Credit Union's final approval.
3. Applications should be received at least five business days prior to the loan due date. Interest will continue to accrue on unpaid balances through the skipped payment period.

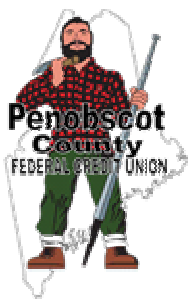
